# What is ASCEPT?

ASCEPT is the leading Society and resource in Australia and New Zealand for the advancement of excellence in the pharmacological and toxicological sciences.

#### Research

Promote and advance research in clinical pharmacology, experimental pharmacology and toxicology, and in drug discovery, development and utilisation.

#### Teaching and training

Promote the teaching and learning of pharmacology and toxicology at the undergraduate and postgraduate levels, and the training of health professionals more generally.

#### **Clinical practice**

Provide leadership in pharmacotherapeutics and quality use of medicines.

#### Advising government

Ensure that ASCEPT has a major role in advising government and other organisations on matters related to pharmacology and toxicology.

### Informing the public

Inform the public regarding important pharmacological and toxicological issues, including drug and chemical safety.

#### International links

Represent Australasian pharmacology and toxicology at an international level.

Foster the development of educational, research and professional partnerships between ASCEPT members and the pharmaceutical, biotechnology and toxicology industries.

ASCEPT is governed by a Council elected by its membership. This body makes all policy decisions and charts the course for the Society.

### Scientific meetings

The ASCEPT Annual Scientific Meeting (ASM), usually held in December, is the largest gathering of professionals in the disciplines of clinical and experimental pharmacology and toxicology in Australasia.
